The officials from RMSCL gave detailed information about the supply process of medicines, distribution and disposal of expired medicines. They were also informed about the online management of medicine supply through e-aushadhi software and equipment maintenance through e-Upkaran.

During the visit, Dr. Vinod Joshi, Principal and Controller (RUHS), Dr. Anil Gupta, Additional Principal (RUHS), and Dr. Mahesh Mangal, Medical Superintendent were present. The Medical Superintendent explained the hospital's operations and informed that a central drug store (Sub-store) is located in the hospital for proper drug management, from where required medicines are distributed to the drug distribution centers(DDCs) in the hospital via online indenting through e-Aushadhi software. Information related to diagnostic equipment, labs, radiology departments, and more was also provided to the visiting team members.

The Managing Director of GMSCL and his team visited the Medical College Drug Warehouse of RMSCL located in Jaipur. Dr. V.P. Meena, the officer-in-charge, while informing about the functioning of the drug store, provided information regarding receipt of medicines from suppliers, maintenance of quarantined/standard/sub-standard/expired medicines, maintenance of cold chain medicines in cold storage, sending drug samples for QC check on a day-to-day basis, distribution of medicines to medical institutions as per the scheduled schedule and requirement after receiving the QC pass report of the medicine and execution of all the work online through software etc. The MD GMSCL and his team appreciated the functioning of the drug store, centralized monitoring of works through software and proper management.
