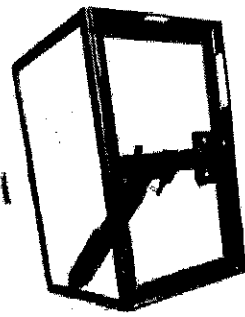

**Revised Additional Mandatory Terms and Conditions for Android Tablet**

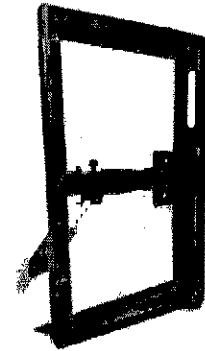
1. These devices are needed for Health Systems of Govt. of Rajasthan. Healthcare workers like Doctors, Nurses, Lab Technicians and Pharmacists etc; will use these devices to provide health services to the patients. Too much of downtime will hamper the timeliness of health services, which is not acceptable, Hence, it is required that the dedicated single brand network is adequately available in the State of Rajasthan So, we need to ensure that the dedicated single brand OEM has a minimum of 1 service center/Authorized service Centre in each of the 33 districts of Rajasthan with GST number to ensure smooth service delivery. Collection centers won't be considered, Details should be provided on OEM website as well. Availability of Customer Service Android application for remote support. Features should include FAQs Call to CS Support center, Remote Control Support and Listing of Service Locations. A list of all such 33 OEM Service Centre/Authorized Service Centre must be attached with technical bid.
2. OEM should have minimum 3 year experience of supply and service of Tablets/IT products in government projects in India.
3. OEM should be from Top-4 as per IDC report of year 2019 (Any quarter)
4. Device should be preloaded with anti-virus solution. It should detect and fix any malware/Virus attack on the device. Latest updates of anti-virus versions should be done regularly. Anti-virus solution should be without advertisements.  
Device OEM / Bidder should also provide MDM which support all tablets and smart phone supplied under this RFP. MDM should-
  - a) MDM should be present in Gartner magic quadrant for enterprise mobility management/ISO 9001:2015 amended upto date. Valid documentation should be submitted in technical bid.
  - b) MDM software will support 3 years software update and free customer care and online support.
  - c) MDM Installation and enrolment should happen automatically by Google Zero touch or OEM equivalent.
  - d) Application blacklist - for eg. WhatsApp, Facebook, Twitter, Instagram
  - e) Application white list - for eg. Govt. of Rajasthan Health Apps. In addition, user should not be able to uninstall this white listed app
  - f) Remotely wiped/factory data reset in case of loss of device. This will ensure that misuse of device doesn't happen
  - g) App installation via push mechanism in devices by admin
  - h) Block factory reset on device (by software/hard keys)
  - i) GPS always on
  - j) Tablet will be locked into single/multi app mode (kiosk mode), wherein only applications which are enabled by department will be visible to the user.
  - k) Admin should be able to take remote control of device from central location to troubleshoot
5. Manufacture/ Bidder must quote the latest model.
6. Demonstration is must for final approval. .



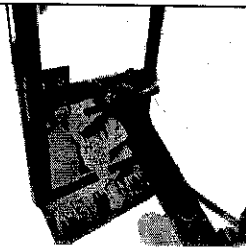

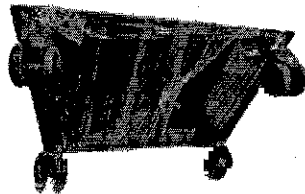

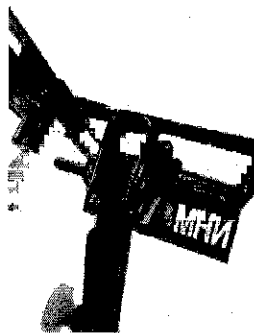
