Revised Technical Specifications of Oxygen Concentrator

- 1. Oxygen concentrator to provide oxygen from ambient air.
- 2. Oxygen flow measured at the flow meter.
- 3. Sound level should be ≤55dB
- 4. Maintenance free rotary proppet v
- 5.
- 6. alve.
- 7. Oxygen purity should be $88\% \pm 2\%$ or more.
- 8. Oxygen output should be at least 5 LPM or more.
- 9. Pressure range should be 6 8 PSI.
- 10. Oxygen tube of 2m length (01no.) with autoclavable polycarbonate humidifier bottle and two cabinet filters should be provided with each oxygen concentrator.
- 11. Supplied with:
 - i. 1 x spare set of tubing.
 - ii. 1 spare sets of humidifier bottle.
 - iii. Two spare sets of cabinet filters.
 - iv. User manual with trouble shooting guidance, in English.
 - v. Technical manual with maintenance and first line technical intervention instructions, in English.
- 12. Power requirements: 220 V/50 Hz.
- 13. Device is produced by ISO 9001 and ISO 13485 certified manufacturer. Related documents/certification shall be submitted along with technical bid.
- 14. Device should be certified ISO 80601-2-69:2014.
- 15. Oxygen failure or Low Oxygen Alarm facility should be available for below 80% oxygen.
- 16. Device should be safety certified according CE / USFDA. Related documents/certification shall be submitted along with technical bid.
- 17. Guarantee: Two years on equipment from the date of installation.
- 18. CMC: CMC may be given @ 5 % exclusive GST (as applicable) and yearly escalation of 5 % previous year's CMC price. The CMC may be awarded for five years (on yearly basis) after guarantee period of two years.
- 19. The service engineer should be based in Rajasthan.
- 20. Demonstration of equipment is must for technical approval.
- 21. Installation will be done by supplier free of cost.
- 22. The company should mention the make & model of the quoted goods and submit the technical brochure of the quoted model in the Technical bid along with compliance sheet as per technical specifications
