#### CLARIFICATION/CORRIGENDUM/ADDENDUM

Subject: Amended Technical Specification and revised bid schedule of bid document of Item Baby Receiving Kit (Blue & Pink Color), under No. F-8( ) RMSC/EPM/M-1/2021-22/NIB-605/903 date: 22.07.2021

In reference to subject cited above NIB-605, various representation received from the firms and issues raised by the bidder are examined by the competent authorities and technical committee. The following clarification/corrigendum/addendum is issued for inclusion in bid document of items as below:-

# Revised Technical Specifications of Baby Receiving Kit-

1. Baby Receiving Kit (Blue & Pink Color) shall contains following items:-

- 2. Jabla made of 100% cotton flannel cloth 125 GSM (+ 5) with front open should have vulcrow in place of buttons.
- 3. Nappy made of 100% cotton flannel cloth 125 GSM (+ 5) with both side string attached (7 inch both side + 1 inch)
- 4. Under Sheet made of 100% cotton flannel cloth 125 GSM (+ 5) with one side cloth and other side polythene sheet (polythene sheet made of food grade plastic with 200 micron + 10 micron) overlocked from all side.
- 5. Blanet made of 100% cotton flannel cloth 125 GSM (+ 5) overlocked from all side.
- 6. Cap made of 100% cotton flannel cloth 125 GSM (+ 5) with both side string attached (4 inch both side + 0.5 inch)
- 7. Socks made of 100% cotton flannel cloth 125 GSM (+ 5)
- Document for the manufacturer Manufacturer should have ISO 9001:2015 Certificate.
   This document shall be submitted along with technical bid.
- Quality of Baby Receiving- Test Report from NABL Accredited Laboratory shall be submitted along technical bid to ensure the quality of Baby Receiving Kit.
- 10. Indira Priydarshini Baby Kit Logo (Annexure-A)-Indira Priydarshini Baby kit, colored sticker Size: 2inch x 4inch shall be affixed on front of packing on Pink color Baby Receiving Kit. The draft of Indira Priydarshini Baby kit sticker is attached in technical bid
- 11. Two Samples of each kit (Blue & Pink Kit) has to be submitted along with technical bid.
- 12. The Baby Receiving Kit shall be supplied with packing of low density polythene (LDPE) with linear low-density polyethylene (LLDPE) octane based with 55 micron.
- 13. A small sticker Size 2.5 inch x 1 inch shall be affixed on each kit with Name:- Baby Receiving Kit (Pink) or Baby Receiving Kit (Blue) during supply.
- 14. On the back of both packing (Blue/Pink kit), The batch/Lot no., details of items contained in kit and Supplier's Name shall be printed by the firm during supply.

- (a) Bidders are requested to send with bid, printed descriptive literature (catalogue) of the quoted goods.
- (b) If bidder had supplied or had a rate contract of quoted goods with any other Govt. institution within one year, he may be asked to provide copies of purchase orders, invoices and rate contracts

M.S.M.E (Manufacturer) shall only be allowed in the Bid.

## Section VII: SSC, Clause No. 10

On receipt of supply at CD, Store, random sampling lot wise shall be done by the members of Technical committee. If the supplied goods are not found as per the Technical Specification of the bid, the supplier has to remove and replace the supplied goods immediately at his own expenses.

### Section V: Bid Data Sheet (BDS), Clause No. 22

This bid does not have provision for parallel Rate Contract (PRC).

## Section VII: SSC, Clause No. 10

On receipt of supply at CD, Store, random sampling lot wise shall be done by the members of Administrative Committee, form by Director RCH, M&H. If the supplied goods are not found as per the Technical Specification of the bid, the supplier has to remove and replace the supplied goods immediately at his own expenses.

## Section V: Bid Data Sheet (BDS), Clause No. 22

To ensure timely supply of the kits, Parallel Rate Contract in the ratio of 60:40 be permitted in the bid.
