## OFFICE ORDER

**Subject:- Relaxation of Supply conditions w.r.t. delivery time to the suppliers of Essential Drugs, Medicines & Surgical/ Sutures for Purchase Orders placed during Jan 10<sup>th</sup>, 2020 to May 8<sup>th</sup>, 2020.**

In wake of rapidly evolving COVID-19 Pandemic, resulted in nationwide Lockdown, various suppliers have requested for relaxation in delivery time without levying Liquidated damages (L.D.).

In view of above and in compliance of Board of Directors decision in 75<sup>th</sup> meeting of Board dated 08.05.2020 vide agenda item no. 16, RMSCL has granted relaxations for **the suppliers of Essential Drugs, Medicines & Surgical/ Sutures for Purchase Orders issued during Jan 10<sup>th</sup>, 2020 to May 8<sup>th</sup>, 2020** with following constraints:-

1. Relaxation of additional 90 Days in stipulated supply period (in addition to the Supply period as mentioned in related purchase order) has been sanctioned without levying Liquidated damages (L.D.) thereon.
2. If supplier fails to supply in stipulated supply period & in additional 90 days. After that, extension in delivery days shall be applicable as per the bid conditions.
3. Above relaxations are not applicable for very essential products used in COVID-19 pandemic i.e. Triple Layer Mask [S85], Hydroxychloroquine Tab IP 200mg [599], Gloves [S5.a, S5.b, S5.c, S6.a, S6.b, S6.c, S89.a, S89.b, S90.a, S90.b, S90.c, S90.d] and Surgical Cap [S86.a, S86.b].
