TERMS OF REFERENCE FOR CONSULTANT (BIO-MEDICAL ENGINEERING)

Background:

The Consultant (Bio-medical Engineering) will work in Equipment Procurement and Maintenance Cell (EPM). The major work are preparation of technical specifications of equipment for procurement, inventory management, technical examination of Bidder's representation and looking after the maintenance works. The equipment maintenance may be undertaken by in-house teams or contracting out to private sector. The EPM-Cell will supervise & monitor the performance of the private sector and in-house equipment maintenance teams.

An outline of the task to be carried out by the Bio-medical Engineer

1. Preparation of technical specifications of equipments and other items and technical examination of Bidder's representation.
2. Set equipment specifications and maintenance standards in consultation with Senior manager/other staff of EPM cell and set specifications, matching with services and level of facility.
3. Identification of vendors/manufacturers and surveying of their units.
4. Advise and assist in the process of procurement of goods and equipment in preparation of procurement plans and finalization of tender / consultancy services etc.
5. Consultant will play an important role in scheduled procurement process.
6. Establish systems to ensure that undertake corrective and preventive maintenance by approved agencies, and advise on evolving equipment strategies.
7. Collection and compilation of requirements for annual equipment procurement and replacement along with necessary maintenance services and budgetary provision etc.
8. Assist in setting up of in-house maintenance services including: Hiring of suitable staff, designing, organising and participating in training the technicians etc. Establishing the maintenance network at regional and district levels based at strategically selected locations throughout the state.
9. Advise and assist in equipment management including installation, commissioning, large-scale maintenance network of bio-medical equipment etc.
10. Other related consultancy work as and when assigned by the MD RMSC.
11. Ensure compliance of maintenance services provided by in-house teams, suppliers/manufacturers or third-party service firms with quality assurance standards defined by EPM.
12. Arrange and supervise necessary training programs for end-users of equipment including ensuring that basic operating instructions and care/first-

line maintenance materials are available at installation sites.

Qualification & Experience:

The Consultant (Bio-medical Engineering) should be a B.E. (Bio-Medical) or equivalent with minimum 2 year experience in equipment management including installation commissioning large-scale maintenance network of bio-medical equipment etc.

Terms and Conditions:

- (i). The appointment shall be initially for six months only.
- (ii). The appointment shall be reviewed after six months.
- (iii). Fees/Remuneration : Rs. 40000/- P/M however may be increased suitably depending upon the qualifications, experience and expertise of consultant.
- (iv). In case journey is performed, he/she shall be eligible for TA and DA as applicable to the scale of state service officers of Government of Rajasthan.
- (v). During the tenure of office the appointee shall keep all official information i.e., obtained or collected strictly confidential.
- (vi). In case any of the above conditions are violated the appointment automatically stands cancelled.
- (vii). The Consultant (BME) may have to travel extensively within the state and outside.
- (viii). The appointment may be terminated by giving a one month notice.
- (ix). The Corporation reserves the right to alter the terms & conditions.
