1. Personnel will leave for foreign travel only after getting their leave sanctioned from the competent authority.

2. Personnel will not stay abroad for more than the approved period, after the end of leave, they will ensure to be present at their duty place. If the employee remains absent at his/her place of duty after the sanctioned leave period, the said employee will be deemed to have been willfully absent from duty and against him/her action will be implemented in accordance with RSR Rules 1951 rule 26 and disciplinary action will be taken as per rules.

3. Leave sanctioned as per this order will not be increased further.

4. Resignation sent from abroad will not be accepted.

5. Competent officers must compulsorily confirm the following before sanctioning leave for foreign travel –

a. The government work/ teaching work of the office / institution will not be affected if the employee goes on leave.

b. The transfer of his/ her workload and important documents has been done completely by the personnel.

c. No departmental enquiry / action is currently proposed or under consideration against the employee.

d. At present no judicial case is pending against the employee.

6. The permission to travel abroad is valid only for the above approved leave period.

7. Before leaving for a foreign trip the concerned office will be informed about the complete address along with mobile number etc. of the stay abroad.

11. The confidentiality of any official record / information will not be breached during the foreign trip.

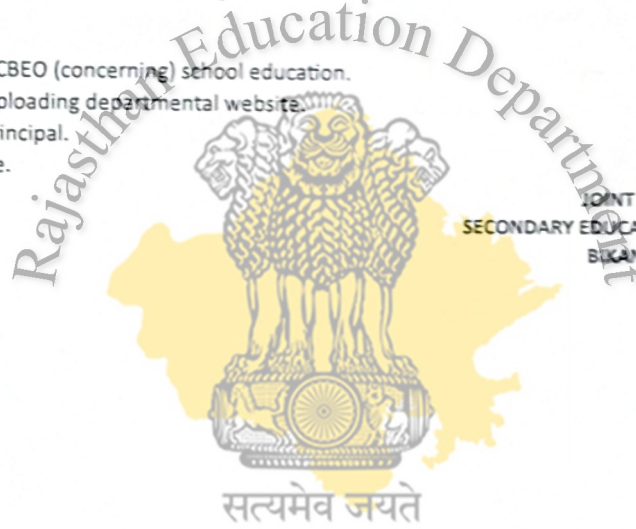
