## Minutes of the 143 <sup>rd</sup> Board Meeting held on 12<sup>th</sup> March, 2018

- 5. Agenda Item No. 143.5: Post facto approval of the fees of Shri P.S. Narsimha, Additional Solicitor General of India; Shri S. S. Shamsherry, AAG ans Shri Amit Sharma, Junior advocate to ASG in the Civil Appeal 8377-8378/2017 State of Rajasthan Vs Rajendra Singh Bhadnari & Others
