Minutes of the 149 th Board Meeting held on 24th June, 2021

149th Meeting of the Rajasthan State Pollution Control Board was held on 24th June, 2021 at 03.30 PM at its Head office, Jaipur. The following were present:

- At the outset, Member Secretary, Rajasthan State Pollution Control Board, Jaipur welcomed the members of the Board. Thereafter, the agenda items were discussed and following decisions were taken:
- 1. Agenda Item No. 149.01: Confirmation of minutes of 148th Board meeting After discussion on the agenda item, the Board members resolved as follows:

Resolution:

149.01: Resolved that the minutes of the 148th Board meeting are approved.

2. Agenda Item No. 149.02: Compliance of decisions taken in 148th Board meetings

Resolution:

149.02: After discussion on the agenda items, the Board members resolved that item No. 148.01, 146.08, 148.03 to 148.07, 148.09 may be dropped as action has been taken and no further action is required.

'3. Agenda Item No. 149.03: Approval for Scheme for Green rating system for industries.

Resolution:

149.03: The Board has perused the scheme developed for Green Rating of Industries by RSPCB jointly with CII and the incentives proposed in the scheme to encourage participation in the scheme. The scheme is approved for implementation.

4. Agenda Item No. 149.04: Approval of funding for establishment of Sewage Treatment Plants in large hospitals of the State.

Resolution:

149.04: The matter was discussed in detail and it was resolved that, Ex-Post-Facto concurrence of the State Board for bearing 12.50 Cr or 50% of the cost of the Sewage Treatment Plants (whichever is less) in large government hospitals associated with Medical Colleges in the State is hereby granted.

5. Agenda Item No. 149.05: Approval of financial sanction of Rs. 675 Lacs to RSRDC Ltd. accorded for construction of Second floor at the Front block and mechanized parking at Head Office building of RSPCB, Jaipur.

Resolution:

149.05: राज्य मण्डल में स्थान के आवश्यकता को दृष्टिगत रखते हुए मुख्यालय के मुख्य भवन (Front Back) पर द्वितीय तल (Second Floor) का निर्माण एवं परिसर के पीछे उपलब्ध स्थान पर वाहन पार्किंग व्यवस्था का निर्माण आर.एस.आर.डी.सी. लिमिटेड के माध्यम से करवाने हेतु राशि रूपये 675 लाख व्यय की स्वीकृति का अनुमोदन किया जाता है। कार्य पूर्ण होने पर आर.एस.डी. सी. आइटमाइज्ड (Itemized) बिल देगा।

6. Agenda Item No. 149.06: Post facto Approval for establishment of 36 Nos of CAAQMS and procurement of 02 Nos. mobile van equipped with analyzers and taking consultancy services of M/s NTPC, Noida for the same.

Resolution:

149.06: The matter was discussed and it is resolved to grant post facto approval for establishment of 36 Nos Continues Ambient Air Quality Monitoring Stations and procurement of 02 Nos mobile van equipped with analyzers and for taking the consultancy services of M/S NTPC, Noida for the same. Further, Chairperson, RSPCB is authorized to take further decision in this regard.

7. Agenda Item No. 149.07: Approval of ongoing bid process for purchasing Laptop/Notebook etc for existing Officers of the State Board and also approval for additional purchasing of Laptop/Notebook for newly appointed Officers of the Board.

Resolution:

149.07: राज्य मण्डल के तकनीकी अधिकारियों हेतु लेपटॉप/नोटबुक इत्यादि की खरीद हेतु वित्त विभाग, राजस्थान सरकार के परिपत्र दिनांक 03.09.2020 के द्वारा जारी निर्देशों के अनुसार शिथिलता प्रदान की जाति है।

8. Agenda Item No. 149.08: Approval of "Special Dispensation Scheme" for Dimensional stone cutting units for a period of six months starting from 01.07.2021 to 31.12.2021 with specific conditions.

Resolution:

149.08: Resolved that approval is accorded for "Special Dispensation Scheme" for Dimensional Stone Cutting units for a period of 6 months starting from 1st July, 2021 to 31st December, 2021, by RSPCB with following conditions;

I. This scheme will be applicable for Dimensional Stone Cutting units which are not yet under the consent management and are seeking consent for the first time.

II. Such industries will apply for consent to establish as well as consent to operate under the provisions of the Water Act, 1974 and the Air Act, 1981 as per the prevailing procedure / fee. However, as a onetime relaxation, such unit will not be required to pay the back fees for the years they were in operation so far.

 Π I. The scheme will also be applicable on Dimensional Stone Cutting industries which have already applied for consent but for the first time and their

applications are pending with the State Board.

IV. The scheme will be applicable only on small scale Dimensional Stone Cutting industries which are established on mine head, industrial land or duly convertible/ allotted land for establishment of Stone Cutting units.

,9. Agenda Item No. 149.09: Post Facto approval for establishment of 10 new Regional Offices of RSPCB and sanction of 80 new posts for these Offices.

Resolution:

49.09: राजस्थान राज्य प्रदूषण नियन्त्रण मण्डल द्वारा 10 नवीन क्षेत्रीय कार्यालयों (बांसवाड़ा, बूंदी, हनुमानगढ़, जैसलमेर, झालावाड़, झुन्झुनूं, नागौर, राजसमंद, सिरोही एवं सवाई माधोपुर) की स्थापना एवं इन क्षेत्रीय कार्यालयों में 80 पदों के सृजन का अनुमोदन किया जाता है।
