OFFICE ORDER

DELEGATION OF POWERS TO REGIONAL OFFICER- REGARDING

In supersession to all the earlier orders/ circulars/ guidelines, the competent authority for grant or refusal of Consent to Establish/ Operate under the provisions of the Water (Prevention and Control of Pollution) Act, 1974/ Air (Prevention and Control of Pollution) Act, 1981, Authorization under the Hazardous Waste Management, Handling and Transboundary Movement) Rules, 2008, Authorization under the Bio-medical Waste (Management and Handling) Rules, 1998, and Plastic Waste Management Rules, 2016 shall be the Regional Officers of the State Board for industries/ projects/ processes/ activities/ mines located within their territorial jurisdiction as follows:-

A. All industries/ projects/ processes/ activities covered under Green category.

B. All industries/ projects/ processes/ activities covered under Orange category, except the following:

1	Building & construction projects more than 20000 Sq mtr
2	Township and area development project 5 Hectare and more / dwelling units 50 and more
3	Food & food processing including fruits & vegetable processing, food additives units with capital investment more than Rs 10 crores
4	Printing ink manufacturing and/ or formulation units with capital investment more than Rs 10 crores
5	Dry coal processing industries involving ore sintering, palletisation, grinding, pulverization.
6	Fertilizer (granulation and formulation only) units with capital investment more than Rs 10 crores
7	Formulation of Pesticides, agro chemicals and so on and R&D Facilities with capital investment more than Rs 10 crores
8	Formulation/ paletization of camphor tablets, naphthalene balls from camphor/ naphthalene powders units with capital investment more than Ps. 10 grants
9	release of drugs only and not for commercial purpose (for sustained release/extended investment more than Rs 10 crores
10	Scrapping centres (for end of life of vehicles and other scraps such as plant and machineries, structural material, railway coaches and wagons etc.)

3	Chlorates, Perchlorates and Peroxides with capital investment upto Rs 10 crores which have storage within threshold quantity indicated in column 3 of schedule 2 and 3 of MSIHC Rules, 1989

Note-

1. The consent applications of all the industry/ project/ process/ activity etc. covered under EIA Notification, 2006 and Aravali Notification, 1992 shall be dealt at RSPCB Head Office irrespective of the delegation of power noted above.

2. The classification of industries in large/ medium/ small/ tiny scale shall be as notified by

the Industry Department.

3. In case any application is refused at the Regional Office level, the decision on the application submitted subsequently by the unit shall be taken by at RSPCB, Head Office level. However, the consent applications submitted after refusal on grounds of deficient documents shall continue to be decided by the concerning Regional Office.

4. Registration under Plastic Waste Management Rules 2016 shall be issued at the Regional

Office level.

5. Regional offices shall be competent to grant/ refuse authorization under HOWMR 2016 in respect of following industries/ activities/ projects/ processes:

Textile industries located in clusters and connected with Common Effluent

Treatment Plant (CETP) at Pali, Balotra, Bithuja, Jasol and Jodhpur.

Steel industries located in cluster and connected with Common Effluent Treatment Plant (CETP).

All industries/ projects/ processes/ activities for which they have the powers to grant/ refuse the consent to establish/ operate under the Air and the Water Acts.

6. However, the powers to revoke/ cancel/ withdraw CTE, CTO and Authorization to all industries/ projects/ processes/ activities irrespective of powers to grant / refuse consent/ authorization shall vest with the RSPCB Head Quarter.

7. Whenever any industry/ project/ process/ activity/ mines falls in two categories or any part falls in higher category shall be taken for decision making and in case of dual

jurisdiction, the Head Office jurisdiction shall prevail.

This bears approval of the competent authority.
