## Office order

### **Fee Schedule for Authorization under the Hazardous and Other Waste (Management and Transboundary Movement) Rules, 2016**

Under the provisions of Hazardous and Other Wastes (Management & Transboundary Movement) Rules, 2016 the project proponent apply for obtaining authorisation under Rule 6, one time authorisation under rule 13 and thereafter, for amendment /modification of the authorization for various reasons including inclusion for additional vehicle for transportation/ additional category of waste for co- processing/ increasing quantity of wastes etc.

It has been decided to impose processing fee for applications for authorization / one time authorization for hazardous waste as follows:-

S. No.	Type of application	Fee
1	Application for authorisation under Rule 6 for generation, collection, storage, packaging, transportation, use, treatment, processing, recycling recovery, pre-processing, co-processing utilisation, offering for sale of hazardous waste and other waste or its renewal	Rs. 5,000 (Rupees five thousand) for each category of Hazardous or other waste
2	One time authorisation for import and export of hazardous or other waste under Rule 13	Rs. 20,000 (Rupees twenty thousand)
3	Authorisation for transportation or inclusion of additional vehicle in already valid authorisation	Rs. 5,000 (Rupees five thousand) per vehicle
4	Authorisation for inclusion of additional waste for co-processing in valid authorization.	Rs. 5000 (Rupees five thousand) for each category of waste

It is further directed that:-

1. The application for authorization should be made atleast 120 days before the commissioning of the plant failing which the application for authorization shall be accompanied with an additional fee of 25% of the prescribed fee.
2. The application for renewal of authorization should be made atleast 120 days before the expiry of validity of authorization failing which the application for renewal of authorization shall be accompanied with an additional fee of 25% of the applicable fee.

3. Where an application for renewal of authorization is made after expiry of the validity of authorization, the application shall be accompanied with an additional fee of 50% of the prescribed fee.

This order shall come into force with immediate effect and shall be applicable to all applications for authorisation and one time authorisation which are received after this order comes into force.
