## Order

In supersession to all the earlier orders/ circulars/ guidelines, the competent authority for grant, refusal and revocation of Consent to Establish/ Operate under the provisions of the Water (Prevention and Control of Pollution) Act, 1974/ Air (Prevention and Control of Pollution) Act, 1981. Authorization under the Hazardous Waste Management (Handling and Trans-boundary Movement) Rules, 2016. Authorization under the Bio-Medical Waste (Management and Handling) Rules, 2016, and Plastic Waste Management Rules, 2016 shall be the Regional Officers of the State Board for industries/ projects/ processes/ activities/ mines located within their territorial jurisdiction as follows:-

- A. All industries/ projects/ processes/ activities covered under Green Category.
- B. All industries/ projects/ processes/ activities covered under Orange Category except the following:-

#### D. Note:

- 1) Criteria for classification of Micro, Small and Medium Enterprise (MSME) shall be in accordance with Ministry of Micro, Small and Medium Enterprises, Government of India notification dated 01.06.2020 summarized below:
  - i. A Micro Enterprise: where the investment in Plant and Machinery or Equipment does not exceed one crore rupees and turnover does not exceed five crore rupees;
  - ii. A Small Enterprise: where the investment in Plant and Machinery or Equipment does not exceed ten crore rupees and turnover does not exceed fifty crore rupees;
  - iii. A Medium Enterprise: where the investment in Plant and Machinery or Equipment does not exceed fifty crore rupees and turnover does not exceed two hundred and fifty crore rupees.
- 2) Delegation of powers in case of industries/ projects/ processes/ activities covered under Environmental Clearance shall be dealt at Head Office except for sectors mentioned at Point C 1 and C 3.

- 3) Subsequent applications after refusal of applications and revocation of Consent to Operate shall be dealt as per delegation of power only. However cases of subsequent applications after directions for closure, will be dealt at Head Office.
- 4) Registration under Plastic Waste Management Rules 2016 shall be issued at the Head Office level.
- 5) Whenever any industry/ project/ process/ activity/ mines falls in multiple categories, the level at which highest category part is to be handled, shall decide all its parts.
- 6) In case any industry/ project/ activity is engaged in utilization of hazardous wastes covered under H&OW (M&TBM), Rules, 2016 (except hazardous waste under schedule IV) as raw material, where Standard Operating Procedure has been issued by Ministry of Environment, Forest and Climate Change/ Central Pollution Control Board, their applications for consent/ authorization shall be granted/ refused by the concern Regional Office or the Group, who is dealing consent/authorization applications of main plant/ process as per delegation of power.
- 7) The authorization applications for transportation of hazardous waste under H&OW (M&TBM), Rules, 2016 shall be granted/refused by the concern Regional Offices or the Groups who is dealing authorization applications for other activities (like generation/ storage/ disposal/ co-processing etc).
- 8) The competent authority for grant or refusal of Consent to Establish/ Operate under the provisions of the Water (Prevention and Control of Pollution) Act, 1974/ Air (Prevention and Control of Pollution) Act, 1981, Authorization under Solid Waste Management Rules, 2016 and Construction & Demolition Waste Management Rules, 2016, which are covered under the purview of EIA Notification, 2006 shall be dealt at Head Office.
- 9) Regional Officers would issue show cause notices for intended refusal/ revocation/ intended directions/ intended imposition of environmental compensation and intended legal action under Water Act & Air Act to the units falling under the jurisdiction of Regional Offices.
