OFFICE ORDER

In order to improve air quality of the State and ensuring strict compliance of provisions of Air (Prevention and Control of Pollution)Act,1981, the State Board vide office order dated 19.01.2023 directed that all the rolling mills using coal as fuel in reheating furnaces shall switch over to cleaner fuel like LPG/PNG/CNG/ LSHS, etc by 18.07.2023. These units were also directed to submit action plan to the State Board with Bank Guarantee of Rupees one Lakh having validity of minimum 02 years. The State Board has received representation from industrial association regarding difficulties in ensuring the compliance of this order by the units.

In view of the above, the matter has been reviewed and the office order issued on 19.01.2023 is hereby partially modified to the extent that the directions shall be applicable in respect of "the rolling mills having production capacity 5000 TPA or more."
