## Office Order

As per prevailing practice in the State Board, Industries/ Projects/ Mines/ Processes/ Activities submit certificate of chartered accountant as a proof of project cost/ investment in plant and machinery etc. while applying for Consent to Establish for the expansion/ modification of existing projects. However, it has been observed that some Industries/Projects/Mines/Process/Activities submit extremely deflated project costs/ investment in plant and machinery.

The matter has been reviewed and it has been decided that Industries/ Projects/ Mines/Process/Activities shall submit a project report for such expansion/ modification of existing project duly certified by Chartered Accountant while applying for Consent to Establish for expansion/ modification of existing project.

All Group In-charges/ Regional Officers of the State Board are directed to carefully examine the project costs/ investment in plant and machinery etc. while processing applications of Consent to Establish for such Expansion/ Modification of existing projects.

In case, the Project Proponent does not submit project report certified by Chartered Accountant with application for Consent to Establish and later on it is found that the project cost was abysmal low and the State Board is satisfied that this was done intentionally, then an Environmental Compensation for an amount not less than the fee for Consent to Establish may be imposed.

This bears approval of the competent authority.
