## Office -Order

The State Board is entrusted with the powers to ensure compliance of stipulated environmental standards prescribed under various acts/ rules. In order to ensure efficient operation, performance evaluation, stringent vigilance, quality control, ensuring compliance with relevant regulations and identification of scope for improvement of various units operational in the State, it has been decided to implement a monitoring mechanism for the 17 category Highly Polluting industries/ CETPs/ STPs / CBWTDFs / CTDFs / and units having ETP 100 KLD and above located in the State.

For this purpose, the Chief Scientific Officer is directed to constitute vigilance teams on rotational basis each month with immediate effect, assigning jurisdiction to each team, to carry out:

- 1. Monitoring /sampling of one CETP/ STP/ CBWTDF/ unit having ETP ≥100 KLD.
- 2. Monitoring /sampling of one 17 category Highly Polluting industries.
- 3. Sampling and verification of problematic areas in the jurisdiction.
- 4. Audit of concerning Regional Laboratory, RSPCB
- 5. Audit of one MoEF & CC recognised private laboratory in the assigned jurisdiction.

The reports shall be issued by concerning Group In-charge Air/ Water/ Noise sections. It is further clarified that the team members of the vigilance teams shall not be part of the analytical teams.

Chief Scientific Officer shall be the nodal officer for the entire matter and shall submit monthly action taken report to the Chairperson Cell along with endorsement to the undersigned at the end of each month.

This order shall come into force with immediate effect and all concerned are directed to ensure adherence to this monitoring mechanism and strict confidentiality of reports and processes.
