Office-Order

It has come to notice of the State Board that in some of the Environmental Clearance letters for mines issued by the SEIAA or DEIAA (Erstwhile), there are omissions or erroneous mention of the name of mineral, lease area and other such typographical errors, which may clearly be adjudged as bonafide errors by mere perusal of the document and its incoherence with the other valid documents related to the lease.


In order to decide the applications for consent to establish and/or consent to operate of such cases of mining leases expeditiously, and to keep a streamlined process in the Head Quarter and all Regional Offices of the State Board, the following steps will be taken now onwards:-

- The lessee shall be informed in writing about the error apparent in the Environmental Clearance letter and advised to get it rectified from SEIAA.
- The lessee should apply to the State Level Environment Impact Assessment Authority (SEIAA) for rectification/correction of the typographical error (s) w.r.t. name of mineral/ lease area, wrong mention of name of district, etc. in the Environmental Clearance order issued to the mining lease.
- The lessee should then submit a proof of having applied as above, alongwith an undertaking to the effect that he has applied for correction / rectification in the Environmental Clearance letter mutatis-mutandis with the lease agreement signed with the Department of Mines & Geology, Government of Rajasthan.
- After submission of the above documents by the lessee to the State Board, the application for consent to establish/operate may be considered on merit for the same mineral, lease area etc. as mentioned in the lease agreement. A copy of consent to operate letter should be marked to Board's Head Quarter and the SEIAA.

Following additional condition shall be imposed in the consent letter:-

- That the consent is subject to decision of SEIAA for correction/ rectification in the Environmental clearance letter.

This bears approval of the competent authority.
