## Office Order

Subject: Clarification regarding delegation of power to grant/refuse consent to establish/consent to operate under the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 and Authorisation Wastes (Management Hazardous and Other Transboundary Movement) Rules, 2016 in respect of industries which are utilizing hazardous waste under Rule-9, engaged in transportation of hazardous waste and import of other wastes mentioned in the schedule III Part -D of the Rules.

Presently there is ambiguity regarding delegation of powers to grant/refuse consent/authorization to those industries which are utilizing hazardous waste as raw material or any other use for which Standard Operating Procedure (SOP) has been issued by CPCB/MOEF & CC or permission under Rule-9 of Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 is required. Some Regional Officers are granting authorisation for transportation of hazardous waste industry/project/activities/processes, for which power to consent/authorisation are not given to R.O.'s, as per delegation of power and also there is no clarity regarding decision making authority on applications of one time authorisation for the traders and actual users of other waste mentioned in the schedule III Part -D. It is hereby clarified that:-

- 1. In case any industry/project/activity is engaged in utilization of hazardous wastes covered under H&OW (M&TBM), Rules, 2016 (except hazardous waste under schedule IV) as raw material, where Standard Operating Procedure has been issued by Ministry of Environment, Forest and Climate Change/Central Pollution Control Board, their applications for consent/authorisation shall be granted /refused by the concern Regional Office or the Group, who is dealing consent/authorisation applications of main plant/process as per delegation of power. Regional Officers and Groups should keep themselves updated about the SOP's issued by CPCB/MOEF & CC time to time and ensure compliance of the SOP's.
- 2. The authorisation applications for transportation of hazardous waste under H&OW (M&TBM), Rules, 2016 shall be granted/refused by the concern Regional Offices or the Groups who is dealing authorisation applications for other activities (like generation /storage/disposal/co-processing etc).
- 3. The applications of one-time authorisation for the traders of other waste mentioned in the Schedule -III part -D shall be dealt as per the office order dated 09/07/2020. One time authorisation applications (for traders) will be dealt at Head Office by HSW Group.

This order shall come into force with immediate effect.
