In compliance to Solid Waste Management Rules, 2016 issued by Ministry of Environment, Forest & Climate Change, New Delhi, and NGT Order in the matter of OA No. 606/2018 dated 16.04.2019, all the cement manufacturing units located within one hundred km from a solid waste based Refused Derived Fuel (RDF) plant are hereby directed to replace at least five percent of their fuel requirement by RDF so produced / recovered segregated non-recyclable plastic (single layered/multi layered) from municipal solid waste received from nearby Municipal Corporations/Nagar Parishads/Municipal Council/Industrial units/Individuals/Gram Panchayats and submit action taken report every quarter to the State Board in the prescribed format. All cement units shall issue certificate regarding quantity received from individual Municipal Corporations/Nagar Parishads/Municipal Council/Industrial units/Individuals.
