Office Order

Powers to issue Registration under Plastic Waste Management Rules, 2016 were delegated to Regional Officers of the State Board within their territorial jurisdiction vide office order no. F 16 (Gen-82A) Plastic/RPCB Vol IV/249-289 dated 07.08.2019.

Ministry of Environment, Forest and Climate Change, Government of India has issued Plastic Waste Management (Amendment) Rules, 2022 to specify guidelines on Extended Producer Responsibility (EPR) for Plastic packaging vide notification dated 16.02.2022.

Further, Central Pollution Control Board (CPCB) has developed centralized EPR portal for Registration of Producers, Importers, Brand Owners (PIBOs) and Plastic Waste Processors (PWPs) so as to implement these guidelines. CPCB has also issued Standard Operating Procedure (SOP) for Registration of PIBOs as well as PWPs. Registration of PIBOs (operating in one or two States) and PWPs is to be done by the State Board through this centralized portal.

As resolved in the 147th Board meeting held on 22.10.2020, the Chairperson of the Board is authorized to exercise all the powers of the Board including powers to grant/renewal/revocation/suspension/cancellation of Registration to producers, recyclers and manufacturers under Plastic Waste Management Rules, 2016. The Chairperson is also authorized to further delegate these powers to other authorities/officers of the Board as per the requirement.

In view of the above and in supersession of all earlier orders, powers to grant/renewal/revocation/suspension/cancellation of Registration under Plastic Waste Management Rules, 2016(as amended) are hereby delegated to the Member Secretary of the State Board.

This order shall come into force with immediate effect.
