Office Order

The State Board, on the basis of recommendation of the committee constituted vide office order dated 16.05.2019 had decided that all Lead Battery recycling industries having both Mandir Furnace and Rotary Furnace operating in NCR sub-region of Rajasthan to install/configure analysers of PM, SO2, NOx and Lead at all applicable emission discharge point of these industries and the same was directed to all such industries vide State Board letter dated 05.09,2018.

In compliance to the CPCB directions dated 18.06.2019, the State Board issued closure direction to all such units which have not yet installed/configured OCEMS with the State Board server on 11.07.2019 under section 31(A) of Air Act, 1981.

Subsequently, various representations have been received from these industries requesting exemption of lead parameters from OCEMS on the grounds that the total installation cost of the lead analyzer is very high while capital investment of the units are quite low and that these parameters were originally not imposed by CPCB and were decided by the State Board only.

The matter has been re-examined, in light of various representations, and it has been decided that henceforth, OCEMS for lead parameter shall not be mandatory in the following Red Category Air Polluting industries located in NCR sub-region of Rajasthan, till further orders.

Further, such industries are directed to ensure compliance of installation / complete configuration of the other three parameters i.e. PM, SO2 and NOx analyzers with the State Board server on the applicable sources of emission as per valid Consent to Operate issued by the State Board.
