Office Order

State Board has issued orders from time to time for delegation of powers to issue closure directions, revocation of closure directions and dealing of subsequent consent applications after closure directions. In supersession to the all earlier orders/directions, following protocol shall be followed in respect of the closure directions:

- 1. Head Office/Regional Officers of the State Board would be competent to issue Directions under section 33 (A) of the Water (Prevention and Control of Pollution) Act, 1974 and section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981 in respect of the industries/mines/health care facilities/projects/processes etc for which they are competent to grant/refuse consent to establish and consent to operate as per delegation of power issued vide order no F-12(5-Adm)/RSPCB//1665-1671dated-24.08.2023 and subsequent order dated 12.10.2023, 03.02.2024 & 10.06.2024.
- 2. Competent authority to revoke directions issued under section 33 (A) of the Water (Prevention and Control of Pollution) Act, 1974 and section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981 and to deal with the subsequent application after closure direction would be the Head Office in all cases.
- 3. Closure Directions under section 33 (A) of the Water (Prevention and Control of Pollution) Act, 1974 and/or section 31 (A) of the Air (Prevention and Control of Pollution) Act, 1981 shall be issued by the HO/ROs in the event of one or more of the following deficiencies/noncompliance:
 - a) Operation of the unit in violation of any Directions passed by the Hon'ble Court/National Green Tribunal/CAQM/TTZ or any other Statutory Authority.
 - b) Operation of the unit without prior Consent to establish and/or Consent to operate.
 - c) Expansion in machinery/process/capacity without prior CTE and CTO
 - d) Use of unapproved fuel (Pet-Coke, FO etc) in violation of the directions passed by the Hon'ble Court/NGT/CAQM.
 - e) Production/operation of the banned item/process.
 - f) Either requisite air/water pollution control measures not installed or Air/water pollution control measures found non-operational or non-compliance of the consent conditions.
 - g) Unauthorized discharge of untreated or partially treated effluent directly on land or into the river or ground water.
 - h) Non-compliance related to installation and operation of the OCEMS.
- 4. Disconnection of electricity supply shall be ensured by the Regional Officer within 48 hours of issue of Closure Directions under section 33 (A) of the Water (Prevention and Control of Pollution) Act, 1974 and/or section 31 DIGITALLIFE Control of Pollution Control of Pollution) Act, 1981.  Report of closure direction in enclosed format (annexure-1) shall be forwarded to the Head Office within 5 days of issue of Directions.

- 6. In all cases of subsequent consent applications received after issue of closure directions, the Regional Officer shall get the application completed in all respect including rectification of the grounds of closure direction and forward the complete case to the Head Office. In case, project proponent fails to complete the consent application or to rectify the grounds of closure direction despite repeated efforts, such applications shall be forwarded by the Regional Officer to the Head Office.
- 7. The consent application so received from the Regional Office shall be processed by the concerned Group In charge. In case consent is granted, the information will be sent to the electricity/water supply Department for restoration.

This order shall come into force with immediate effect.
