Rule 23 (2) of the Hazardous and Other Wastes (Management and Transboundary Movement) Rules 2016 provide that the occupier and operator of the disposal facility shall be liable to pay financial penalties as levied for any violation of the provisions under these rule by the State Pollution Control Board with the prior approval of the Central Pollution Control Board.

The guidelines on "Implementing Liabilities for Environment Damages due to Handling & Disposal of Hazardous Waste and Penalty" prepared by the CPCB stipulate that every SPCB shall constitute Hazardous Waste Incident Response Team (HWIRT) for estimating/implementing environmental damage liability and financial penalty.

In order to implement aforesaid provisions, HWIRT is hereby constituted at all Regional Offices with the Regional Officer as the team leader and one officer each from Engineering and Scientific cadre as its members.

HWIRT shall forward the cases of violation after assessing environmental damages liability and financial penalty along with recommendations to the GIC (Hazardous) at the RSPCB Head Quarter for forwarding it to CPCB for its approval.

This bears the approval of the competent authority.
