7. Group In-charge of Grievances and Complaints, RSPCB, Jaipur - Member Secretary of Committee

A. The committee shall undertake following functions

- a. Consider the matters related with Notice/demand for justice in the State Board.
- b. Examine thoroughly every case on merit and make reasoned recommendation after due consideration of legal opinion, relevant Acts, Rules, Notifications, Circulars, Judicial Precedents and other relevant material regarding acceptance or partial acceptance or rejection of the claim, keeping principal of natural justice in mind.
- c. Any other pre-litigation matters in line with the State Litigation Policy 2018
- B. Group In-charge of Grievances and Complaints, RSPCB, Jaipur shall be the nodal officer for receipt of notice for justice/demand for justice
 - a. The nodal officer shall make a separate register for the notice for justice/demand for justice
 - b. The nodal officer shall ensure such notices/demands are placed before the committee within seven days of the receipt of such notice/demand.
 - c. Place before the committee, relevant records previous aferone on same points of any other party or the same party, and decision taken/recommends as made.
 - d. The nodal officer shall made available the relevation state of the committee at least 5 days in advance that the least 5 days in

- f. The nodal officer shall communicate the decision with reasons through post and/or e-mail to concerned person without delay and in all probability before expiry of the notice period.
- C. Absence of any member of committee except the chairperson of the committee shall not vitiate the proceedings and/or recommendations of meeting.
- D. The recommendations of the Pre-Litigation Monitoring Committee shall be submitted to the Chairperson, RSPCB, for final decision on the notice.
