SOP for empanelled Experts for conducting the cross verification of rated industries/activities in Green Rating Scheme

Background:

RSPCB and CII has jointly launched the program for Green Rating of Industries in Rajasthan in July 2021. CII has been managing the implementation of green rating in industries based on GreenCo rating guidelines and the assessment is being be carried out by the empaneled assessors by CII.

The green rated industries will be eligible for incentive scheme as proposed by RSPCB vide their office note dated 27th July 2021. Though the process adopted by CII is robust, However, it has been decided to introduce a cross verification of assessments carried out by CII for few assessments as sample to maintain high standards of transparency and to ensure that the assessments are credible, impartial and replicable. This cross verification of assessment will be carried out by experts from technical institutions, as identified and empanelled by RSPCB.

The objective of this document is to highlight the proposed methodology of conducting cross verification of green rated industries in Rajasthan under the scheme of RSPCB — CII Green Rating of industries.

· Methodology for Cross Verification:

- RSPCB has empaneled MNIT, Jaipur and IIT, Jodhpur as experts for cross verification of green rating assessments
- CII will conduct a session on Green Rating for the identified experts with an objective of sharing the methodology, coverage, assessment criteria and evaluation checklist. This will be conducted for any new experts identified in future, so that, the experts are fully familiar with the rating guidelines.
- 3. CII will share the list of GreenCo rated companies to RSPCB on a quarterly basis.
- RSPCB will identify sample companies for cross verification by technical experts. This
 will be about 10 to 20% of the total assessments carried out by CII.
- Based on the shortlisting, CII / RSPCB will communicate to the green rated company with a copy to RSPCB / CII and identified technical expert.
- CII and the concerned Regional Officer will facilitate the visit by experts to the identified green rated plant for assessment.
- 7. CII will provide required background material such GreenCo final score band of the unit, GreenCo closing meeting presentation of the unit, empty scoring sheet for GreenCo Parameters to the empaneled Expert for conducting the cross verification. CII representative will facilitate the cross-verification process for the first two verification visits made by the empaneled expert or newly inducted empaneled expert.

- Empaneled Experts will select atleast 07 GreenCo Parameters (on random basis) for
 evaluation. However, number of parameters for evaluation can be revised suitably based
 on the feedback from the Experts and experience gained from the cross-verification
 process.
- 9. Based on the visit, the expert will provide a report to RSPCB
- 10. RSPCB will communicate the outcome of the expert assessment to CII and the green rated unit.
- 11. Site visit activities for cross verification of rated industries

1	Brief presentation by the Green rated unit on the overview of the plant/ unit and the GreenCo Rating process
2	Plant visits to understand the initiatives implemented by the unit and systems followed in various areas related to green rating
	 Shop floor / production area, major projects implemented by the plan- related to Energy Efficiency, Water, Waste and Material management and other important GreenCo areas
	 Solid waste management areas Waste water treatment Utilities like compressor house, pump house etc.
3	Sharing of required data to the emplaned experts by plant officials. The experts will preferably use data from authentic sources like analysis reports of samples conducted by RSPCB, Online Emission Monitoring data, Continuous Ambient Air Quality Monitoring Data etc.
4	Submission of scoring sheet, findings & remarks by the expert to RSPCB within a week time.
