Office Order

The State Board vide its office order No. F12(PSC-21/RSPCB/2005-2050 dated 28/09/2021 had revised the frequency of inspection and monitoring for all industries/facilities/processes/mines etc.

Recently, the matter of Inspection/Monitoring in case of Textile Process Houses has been reviewed by the State Board and it has been decided that *"the Inspection/Monitoring frequency in case of Textile Process Houses, shall be four months i.e., thrice a year, with a mandatory Inspection/ Monitoring between August to September of each year i.e. during Monsoon season"*.

Rest of the frequency of Inspection/Monitoring schedule shall remain same in case of all other Industrial Category/ Facilities as issued vide Office Order No. F12(PSC-21/RSPCB/2005-2050 dated 28/09/2021.
