Office-Order


The State Board had issued office order dated 12/01/2022 restricting industries installing ETP in one unit & connecting waste from more than one unit for treatment. In the order it was further directed that multiple units presently operative with one ETP shall install individual ETPs within a period of one year from the date of issue of this order. The State Board has received representation regarding difficulties in complying with the order by existing units.

Thereafter, the matter has been re-examined and the State Board office order dated 02.04.2019 is partially modified to the extent that:-

1. The para no. four "**It is further directed that multiple units presently operative with one ETP shall install individual ETPs within a period of one year from the date of issue of this order**" shall be deleted.
2. Following shall be inserted "**That the existing such units having already established common ETP after taking CTE/CTO from the State Board and the units which have already obtained CTE for common ETP will not come into the purview of the office order dated 12.01.2022**".

In order to keep check on leakages through underground closed conduits, water meters shall be provided at the outlet of remote units making discharge into common ETP and at inlet of the industry where common ETP is located. Daily meter reading shall be recorded by individual units and compare to confirm that the entire effluent discharge by individual unit so that any problem related to leakage can be detected.

This bears approval of the competent authority.


