In order to address the need of industries for modernization in light of changes in Technology and Machinery in Textile Sector, the State Board in supersession to Office Order No F.14 (5) Adm/RPCB/Plg/4199-4151 dated 16.06.2020, issue following order for addressing the issue of change in Plant & Machinery in small scale textile industries connected to CETP.

The units Consent to Establish application shall be considered on submission of prescribed documents as per checklist of State Board and fulfilling following conditions:-

1. Consent for change of Plant and Machinery shall be allowed only in those textile industries that have valid membership of the CETP Trust.
2. Consent for change of Plant & Machinery will be allowed only after that the unit submit revised connectivity of CETP Trust incorporating changes in Plant & Machinery.
3. Consent for change of Plant and Machinery shall be considered for effluent discharge allowed in the valid Consent to Operate of State Board. No increase in trade effluent generation beyond the consented capacity of the State Board will be allowed.
4. The unit will install Primary Treatment Plants (PTP) and will discharge effluent complying with prescribed standards. The unit shall install automated SCADA system compulsorily at the outlet and shall maintain the record of discharge.

The Consent for change of Plant and Machinery so granted shall be subject to the various orders/judgments passed by the Hon'ble Rajasthan High Court, Hon'ble National Green Tribunal (NGT), Hon'ble Supreme Court or any other court of the nation.

All concerned are directed to ensure compliance of the order with immediate effect.
