#### 1. **Bidding Process:**

- a) Rajasthan State Pollution Control Board has adopted online single stage two parts process involving Technical Bid and Financial Bids for selection of the Bidder for award of the Project (collectively referred to as the — Bidding Process). The first part involves technical qualification and short listing of the qualified Bidders who become eligible for opening of their Financial Bids
