- 5. The RSPCB reserves the right to accept bid not necessarily the lowest, reject any bid without assigning any reason.
- 6. Bidder should provide copy of Permanent Account Number (PAN) allotted by Income Tax Department.
- 7. Bidder should provide copy of GST certificate.
- 8. GST will be extra as per the government norms.
- 9. Payment will be made after successful completion of the above work.

- 10. Accident protection insurance of the workers shall be borne by the Service Provider and RSPCB shall not be responsible for any of such accidents, if happens during the execution of the work.
