Sub: Establishment of State Control Room to monitor enforcement of SUP ban

- 1. A State Control Room (SCR) to monitor enforcement of SUP ban in the State of Rajasthan is hereby established in the Rajasthan State Pollution Control Board (RSPCB) in accordance with the decisions taken by the National Task Force in its meeting held on 26.06.2022
- 2. The SCR shall become operational w.e.f. 04.07.2022 and facilitate activities related to effective implementation of SUP ban including the following:
 - (a) Provide assistance, guidance, clarification and information as may be sought by various stakeholders regarding ban on SUP items, which may include following:
 - Specific items covered under/excluded from SUP ban.
 - Alternative to banned SUP items and their availability in Rajasthan.
 - Guidance for filling of complaints on SUP Public grievance App.
 - Guidance for operation of SUP compliance monitoring portal by ULBs.
 - Issues related to switching over to alternatives including issue of consent/registration of plastic producers.
 - Compostable Plastic manufactures (Certification, procedure, testing facilities etc.)
 - (b) The SCR shall monitor enforcement of SUP ban through ULBs and Regional Offices of RSPCB and report compliance status through SUP Compliance Monitoring Portal.
