### **Implementation of online module for submission of authorization applications under Solid Waste Management Rules, 2016**


Under the provisions of Solid Waste Management Rules, 2016, urban local body or an operator of a facility or any agency authorized by local body responsible for the processing or disposal of solid waste is required to obtain authorization from State Pollution Control Board. Module for online submission of application under Solid Waste Management Rules, 2016 is already operational.

The application for authorization shall be accompanied with following documents:-

- i. Copy of consent to operate under Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981.
- ii. Affidavit in prescribed format.

As per the above Rules, the State Board shall issue authorization within a period of 60 days of the making an application in this behalf complete in all respects to the State Board.



1. That I am a Director/Proprietor/Partner/Power of Attorney holder (strikeout whichever is not applicable) of M/s..... and authorized to sign the prescribed application for seeking consent/authorization and documents.

3. That I have applied for Fresh/Renewal of Authorization under Solid Waste Management Rules 2016(hereinafter referred to as the Rules).
4. That I am aware about the technical, scientific and legal requirement of Authorization for collection, storage, segregation, transportation, treatment, processing, recycling, co-processing, utilization, disposal of solid waste under provision of the Rules.
5. That solid waste will be procured and/or disposed off as per category, quantity and mode of disposal mentioned in the authorization.
6. That in case of any expansion or change in waste quantity and/or addition of waste, industry/facility shall be liable to obtain fresh authorization
7. I will ensure that the solid waste will be handled, managed & disposed off strictly in accordance with the Rules as amendment time to time.
8. I am aware that non-compliance of the Rules or any of the conditions contained in the authorization, industry shall be liable to automatic cancellation/revocation of the authorization.
9. That industry/facility will be responsible to comply with all other related Act/Rules notified time to time by MoEF&CC, CPCB and RSPCB or any other Competent Authority for management of the solid waste.
10. That the solid waste viz process rejects generated from the process will be disposed in scientific manner as per the provisions of the Rules.
11. That the Annual Report shall be filed as specified under sub rule (6) of Rule 19
12. That I will comply with the provision of Solid Waste Management Rules, 2016.
13. That I will ensure proper operation/maintenance of system for the control of fugitive emissions from the various activities/processes so as to ensure clean and safe environment in and around its premises.
